Latest News

SCOAP³ now comprises 47 countries and Intergovernmental Organisations. As of December 2015 Australia is part of the SCOAP³ community, which means that all continents are now represented in the consortium. The first Australian institutions signed the MoU in December 2015 and contribute retroactively from 2014 onwards their savings on subscriptions:

- Queensland University of Technology (QUT)
- <u>University of Melbourne</u>
- University of Western Australia (UWA)
- Griffith University

Thanks to the strong support of the entire Australian OA community we expect more institutions from the region to join soon.



Partnership Activity

On November 18th 2015, SCOAP³ held its 2nd Forum entitled "The impact of SCOAP³". The SCOAP³ Executive Committee, joined by several guest speakers, presented on the impact of the initiative for libraries, scientists and funding agencies. The SCOAP³ Governing Council held its fifth meeting at CERN on December 11th 2015 attended by almost 40 delegates and observers from all geographical regions. The larger part of the meeting was dedicated to the preparation of the second 3-year cycle of SCOAP³ (2017-2019). Presentations from the Executive Committee and discussions in the assembly focused on the re-negotiation of publisher contracts and the revised distribution of HEP authorship used in the calculation of contributions to the SCOAP³ collaboration.
